I Hereby Certify that HANS HEALTH ACTION NETWORK SOCIETY has changed its constitution by changing its purposes to the following:

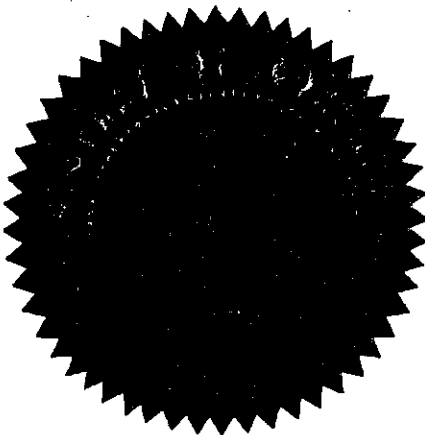
2. (a) to investigate, examine, compare, and research all methods, types, and systems of preventative Health care and natural therapeutics including but not limited to treatment and care of the physically, mentally, and emotionally afflicted.
- (b) to serve as an educational and non-profit organization for the dispensing of factual information.
- (c) to contact, inform, and exchange researched studies with all interested health care professionals.
- (d) to engage in and encourage studies and research into the extension of human life.
- (e) to work with and exchange information with Societies operating in specific fields of private and public health care.
- (f) to work with and support civic, municipal and other health care services to the benefit of all Canadians.
- (g) to work with government at all levels to improve and expand the scope and quality of PREVENTATIVE HEALTH CARE SERVICES available to Canadians and as an ancillary matter to present the Society's view in health issues consistent with the law on charities but not for the purposes of lobbying.
- (h) to encourage individuals to accept responsibility for their own health.

- (i) to participate in the development of programs to foster a balanced lifestyle in order to promote the development of optimum health.
- (j) to raise funds for the purpose of researching all aspects of Health Care without limiting the scope or areas.
- (k) to research projects based on need as recommended by the Directors, Executive Committee and expert advice available, consistent with the dominant purpose of the Society.
- (l) to acquire capital funds by means of gifts, bequests and donations.
- (m) to give financial assistance to qualified health care therapists in need, in the pursuit of their profession.
- (n) to acquire property, buildings and equipment, together with qualified professional instructors for the purpose of establishing a College of Natural Healing in B.C. to ensure suitable courses to meet professional needs and standards, but not for the purpose of issuing a diploma or degree.
- (o) to carry on business activities provided such business activities are permitted under the Society Act (BC) from time to time in force and provided such business activities are permitted to a charity under the Income Tax Act from time to time in force.


